Indiana Heartland Federal Credit Union has announced it will be giving two \$500 scholarships to members attending college in the fall.

The scholarship is open to both high school seniors and college students. Criteria are determination, work history, academics, church, and community activities. Applicants must have a 3.0 GPA.

## INDIANA HEARTLAND CREDIT UNION SCHOLARSHIP

1. The Credit Union will present up to two \$500 scholarships annually to worthy recipients.
2. Students must enroll in an accredited institution in a program of at least one academic year.
3. Previous high school graduates, current college students, and high school seniors may apply.
4. Recipients shall be chosen by the Board of Directors or a committee approved by the Board.
5. Applicants shall have at least a 3.0 GPA in high school and college (if applicable). They shall submit their latest transcript (unofficial is ok) from high school or college, even if they are not currently attending.
6. Checks shall be made co-payable to the student and institution on presentation of his/her upcoming class schedule. The grant is for the upcoming academic year, but it may be used for summer school immediately before or after that academic year.
7. Criteria are determination, goals, work history, academics, church, and community activities all.
8. A **typed** essay must be submitted on the topic, “How Is Our Credit Union Beneficial to Our Community and Myself?”
9. The deadline shall be April 19<sup>th</sup>.
10. Winners will be announced at the annual meeting in May. Certificates will be presented at the meeting and at the students’ high school awards day.
11. Applicants must be a member of Indiana Heartland Credit Union by December 31<sup>st</sup> of year prior to deadline.
